Europe is our home: Growth Plan for the Western Balkans

"Europe is our home. In it, we have always lived together, we travel the same roads, and we are driven by the desire for a better life."

Aim:

The Delegation of the European Union to Serbia aims to initiate a societal dialogue regarding how Serbia should utilize the funds from the Growth Plan. This topic will be discussed during panel events scheduled for May in Subotica and Niš, coinciding with the celebration of Europe Day and the Europe is Our Home campaign.

Introduction:

The Growth Plan for the Western Balkans is part of the aspiration to make Europe a better place to live for all people together. The region has always been historically, culturally and economically linked to the European Union, which is the largest donor in Serbia, but also the most important trade and economic partner. About 65 percent of Serbian exports go to EU member states, and more than half of the total import of goods to Serbia is from the EU.

The European Union created a unique Growth Plan to bring the region and Serbia closer economically to the Union and to contribute to the accelerated development of the region. Not only will the investment help the economies of the region to grow and develop faster, but the Growth Plan will also lead to the acceleration of the expansion process, i.e. the implementation of the necessary reforms in the countries of the region. More integration means a better quality of life for all citizens of the region.

A total of 6 billion euros have been allocated, which will be used to finance some of the most important projects in the Western Balkans. The European Commission estimates that the Growth Plan could double the region's economy in the next 10 years.

Serbia, as the largest country in the region, will have the opportunity to apply for the largest part of the funds, and out of six billion, two represent non-reimbursed aid, while 4 billion will be allocated through very favourable loans. Joining the single European market has always been one of the main drivers of the integration process because it is also the main driver of the economic growth of countries when they become members of the European Union. When we talk about Serbia, its GDP per capita is

currently only 44 per cent of the EU average, and the goal of the Growth Plan is to reduce that gap.

Through the Growth plan, some of the most important projects in the region will be financed, and the countries of the Western Balkans should make individual plans with detailed reforms that they will implement.
